

### **Protecting Your Child Online**

Due to the COVID 19 pandemic, the internet has become an important part of our lives. Children are using technology and the internet more than ever to access online classes, homework, and resources. Internet access is not without risk, and some parents may be at a loss on how to monitor their children's internet use to protect them from things such as cyberbullying, money theft, or exposure to inappropriate content. We've gathered a list of tips to help parents make smart decisions with their smart devices to keep kids safe online.

- Cyberbullying prevention talk to your kids about online etiquette, and thinking before they send a message. If they shouldn't say it in person, they shouldn't say it online.
- Streaming services most streaming services have parental controls that you should utilize to ensure they can only access age-appropriate content. A time limit should also be set for screen time.
- Gaming safety online games often have chat features. Make sure your child's account is set to private, monitor their communications regularly, and talk to them about never sharing personal information online.

- Lead by example don't text and drive, and don't bring your phone to the dinner table.
- Social media safety talk to kids about the
  permanence of social media posts, and how deleting
  something does not mean it's gone forever. Ensure
  location access on their accounts is blocked and
  adjust settings to make their accounts as private as
  possible.
- Create awareness show your kids examples of what to look for when determining whether a website is safe to access, and how to avoid risky sites and apps.

## **Field Trips**



Attorney **Richard Arsenault** has been selected to the 2021 Top 50 Lawyers in America list by the Top Lawyers in America.


NBA employee **Boyd** recently celebrated his 40th work anniversary with our firm, and the office celebrated with a delicious cake in appreciation of his work.
