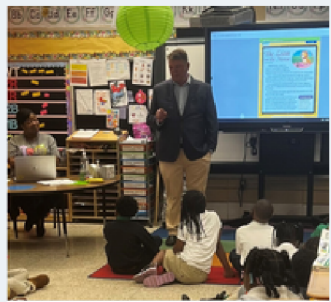

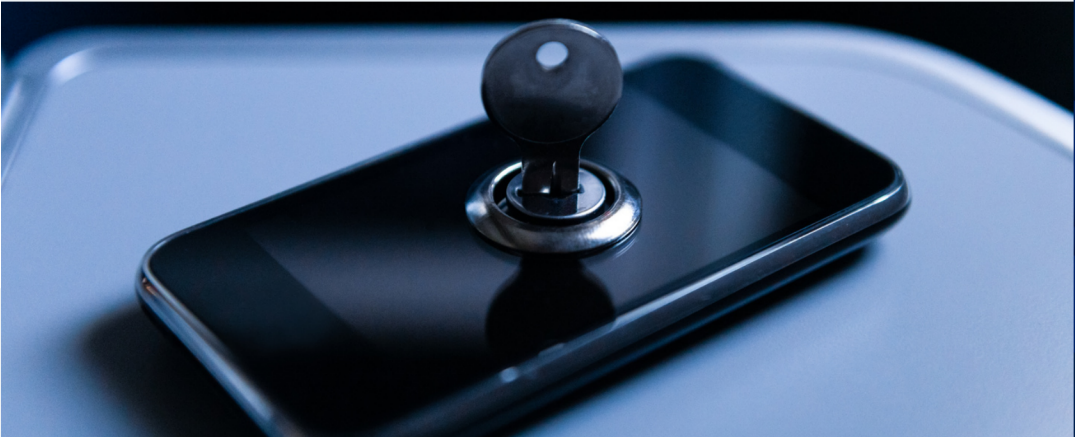
CARING FOR OUR COMMUNITY
